### The following is a reminder of the Golf Cart Lease Program

**TERMS & CONDITIONS:** Lessee must be a member in good standing of the Diamond Trail Golf Club. The lease entitles any family member age 14 and older use of the Golf Car (s). There is no restriction on the number of lease agreements that a member (Lessee) can purchase. The Lessee shall have use of a Golf Car (s) for one season of play at Diamond Trail Golf Club. This lease can neither be cancelled nor modified except by written notice by the Lessee and agreement by the Diamond Trail Golf Club Board of Directors. This lease DOES NOT entitle Lessee to take the Golf Car from DTGC premises.

**LESSEE'S WAIVER OF DAMAGES:** Lessee acknowledges that it will agree to pay for any damages that are sustained to the said Golf Car (s), other than normal wear while in the possession of the Lessee or Lessee's family member (s). Lessee further agrees to hold the Diamond Trail Golf Club or any of its agents, free and harmless from any damages of said Golf Car (s). The Lessee acknowledges that the Lessee and family member (s) are familiar with the operation, ability to control, and use of said Golf Car(s).

### Golf Cart Lease Key

**TERMS & CONDITIONS:** This key is issued for the calendar year of your full paid cart lease agreement. This key must be returned to Diamond Trail Golf Club on or before 01/31/21.

In turn for loan of this key, I agree:

- 1) not to give or loan the key to others; 2) not to make any attempts to copy, alter, duplicate, or reproduce the key; 3) to use the key for authorized purposes only; 4) to safeguard and store the key securely; 5) to immediately report any lost or stolen key; 6) produce or surrender the key upon official request.

I also agree that if the key is lost, stolen or not surrendered when requested a charge that reflects the cost of changing any and all locks affected may be assessed.

- Entitles one designated person in the household to the use of one seat on a DTGC golf cart for one season.

- Applicable if you own your own cart and would like to use it instead of leasing a cart from DTGC.
- Allows any household member to use the cart for the year.

\_\_\_ **Cart Shed Rent-** \$267.50 (includes tax) or 22.30 monthly

- Store your own cart in the DTGC cart shed. Cart Shed rent includes trail fee.
